

Maybank CNY 2023 Watch to Win Contest - Terms & Conditions

- 1. The "Maybank CNY 2023 Watch to Win Contest" (Contest) commences on 23 January 2023 at 10:28:00 (MYT) and expires on 12 February 2023 at 23:59:59 (MYT) (both dates inclusive), unless notified otherwise ("Contest Period")
- 2. This Contest is organised by Malayan Banking Berhad (Company Registration No.: 196001000142) ("Maybank") and shall be subjected to the Terms and Conditions herein. ("Terms and Conditions").
- 3. By participating in this Contest, the Eligible Participants (as defined in Clause 4 below) hereby expressly agree to be bound by these Terms and Conditions and any decisions made by Maybank in respect of the Contest shall be final and binding.
